RATES AND TERMS

Must be 30 year fixed rate.
Seller can pay all closing costs.
Can be combined with NH Housing

PROPERTY REQUIREMENTS

Single Family Homes
FHA approved
Condos/Townhouses
Mobile Homes ONLY if brand new, on own lot, not in a park, purchased from an approved dealer-contractor
Lot value no more than 30% of total value
Lot cannot be subdividable
House must have a refrigerator

CREDIT HISTORY

620 minimum credit score required

Credit Reports must show no more than one payment over 30 days in the past 12 months

INELIGIBLE AREAS

Concord, Derry, Dover, Hudson, Keene, Londonderry, Manchester, Merrimack, Nashua, Portsmouth, Rochester, Salem and parts of Goffstown and Hooksett

Bankruptcy/Foreclosure must be over 36 months old.
